

EverETH Privacy Policy

At EverETH, accessible from EverETH.net (the "Website"), one of our main priorities is the privacy of our visitors and users. This Privacy Policy document, together with our User Agreement and Terms, outlines which personal data about you we collect, use, disclose, share or otherwise process when you use this Website, our products, and our services. Please read this policy carefully to understand our practices on protecting your personal data.

Introduction

This is the privacy statement of the EverETH community operating the EverETH project ("website", "we", "us", "our"). EverETH and our existing or future affiliates are the controllers with respect to your data. This Privacy Policy applies to EverETH.net and all EverETH products and services.

EverETH cares about protecting your right to privacy in all regions where we operate. While complying with local laws, we are committed to implementing the personal data protection standards imposed by the General Data Protection Regulation (GDPR) across all EverETH entities.

When we collect personal data, we generally act as a "data controller" as defined in applicable law. The exact categories of data we collect, why we collect it, and your opt-out choices depend on the service you use, as described below.

Children's Privacy

The Website and EverETH products and services are not intended for children under 18. We do not knowingly or intentionally collect information about children who are under 18 years of age.

Information We Collect

The website may collect the following information:

1. **Information provided by the User**: When using our services, subscribing to updates, responding to surveys, filling out forms, or corresponding with us, you may be asked to provide personal information such as name, address, email, phone number, financial/payment information, cryptocurrency addresses, ID/passport copies, date of birth, or other identification data required for compliance purposes.

2. **Information collected automatically**: On each visit to the Website, we may automatically collect technical information such as your IP address, browser type and version, time zone, operating system, and website usage data like pages visited, links clicked, and time spent on pages.

3. **Cookies and Tracking Technologies**: We may use cookies, web beacons, and other tracking technologies to collect information about your device, browser, pages viewed, and interactions with our services.

4. **Survey Information**: If you participate in our surveys, we collect the information included in your survey responses.

5. **Third-Party Information**: We may receive information about you from third parties such as our partners, payment processors, advertising networks, credit reference agencies, or other sources for the purpose of providing our services or complying with legal requirements.

6. **Location Data**: If you use a location-enabled device, we may collect location data or use various means to determine your location.

Use of Information

We may use your personal data for the following purposes:

- To provide, maintain, and improve our products and services

- To send periodic emails with products and services information

- To follow up on inquiries and correspondence

- For marketing and retargeting purposes

- To comply with legal obligations such as Anti-Money Laundering (AML) and Counter-Terrorist Financing (CTF) regulations

- For any other purpose for which the information was collected

You can opt-out of receiving marketing communications from us at any time by contacting us using the information provided in this Privacy Policy.

Consent and Rights

Your personal data may be processed only if you have unambiguously given your consent, or if the processing is necessary for the performance of our services, compliance with legal obligations, or for the public interest, as permitted by applicable law.

You have the right to access, rectify, delete, or portability of your personal data held by us. You may exercise these rights by contacting our Data Protection Officer at the address provided in this Privacy Policy.

Data Sharing and Transfer

We may share your data with:

- Partners providing our services

- When using interactive areas of our Website or forums, some information may be displayed publicly

- Courts and government authorities if required by law or legal process

- If we believe your actions are inconsistent with our terms or policies, or to protect our rights and safety

- Between and among EverETH entities
- With your consent or at your direction

We may transfer your data internationally or cross-border for the purpose of providing our services, updates, and responding to your inquiries. By using our services or communicating with us, you consent to our processing and disclosure of your personal data as described in this Privacy Policy.

Security

We implement physical, technical, and administrative security measures to protect your information from unauthorized access, disclosure, or misuse. However, no system is completely secure, and we cannot guarantee the absolute security of your information.

Third-Party Websites and Social Sharing

Our Website may contain links to third-party websites or social sharing features that are not owned or controlled by EverETH. We are not responsible for the privacy practices of such third parties. We encourage you to review the privacy policies of those entities.

Data Retention and Disposal

We will retain your personal data for as long as needed for the provision of our services or as required by law. When we receive requests to dispose of personal data records, we will handle those requests within a reasonable time frame and ensure proper disposal mechanisms to prevent data leaks.

Personal Data Breaches

In the event of a suspected or actual personal data breach, we will conduct an internal investigation, take appropriate remedial measures, and notify the relevant supervisory authorities and data subjects as required by law.

Governing Law

By using our services or providing information to EverETH, you consent to the processing and transfer of information in accordance with the laws of the jurisdiction in which EverETH operates.

Changes to this Privacy Policy


We may update this Privacy Policy from time to time. The revised policy will take effect immediately upon publication. We will notify you of significant changes by posting a Privacy Notice on our Website.
